

#### A.H. AT TURNPIKE SOUTH COMMUNITY DEVELOPMENT DISTRICT PUBLIC HEARING & REGULAR BOARD MEETING JUNE 26, 2018

#### A. CALL TO ORDER

Mrs. Perez called the June 26, 2018, Regular Board Meeting of the A.H. at Turnpike South Community Development District to order at 10:36 a.m. in the Third Floor Conference Room of the Crexent Business Center located at 6625 Miami Lakes Drive, Miami Lakes, Florida 33014.

#### B. PROOF OF PUBLICATION

Proof of publication was presented that notice of the Regular Board Meeting had been published in the *Miami Daily Business Review* on October 10, 2017, as part of the District's Fiscal Year 2017/2018 Regular Board Meeting Schedule, as legally required.

#### C. ESTABLISH A QUORUM

A quorum was established with the following Supervisors in attendance: Chairman Karl Albertson, Vice Chairman Ravi Latchman and Supervisor Logan Bell and it was in order to proceed with the meeting.

Staff in attendance were: District Manager Gloria Perez of Special District Services, Inc.; and General Counsel Vanessa Steinerts of Billing, Cochran, Lyles, Mauro & Ramsey, P.A.

#### D. ADDITIONS OR DELETIONS TO THE AGENDA

Mrs. Perez asked that the Board consider accepting a letter of resignation from Supervisor Joseph Guttuso (Seat #5), effective as of May 24, 2018. A copy of the letter was presented for District's records and was also distributed as handout.

A **MOTION** was made by Vice Chairman Latchman, seconded by Supervisor Bell and unanimously passed accepting Joseph Guttuso's resignation from Seat No. 5 and simultaneously declaring a vacancy in Seat # 5.

#### E. COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON THE AGENDA

There were no comments from the public for items not on the agenda.

#### F. APPROVAL OF MINUTES

#### 1. May 22, 2018, Special Board Meeting

Mrs. Perez presented the minutes of the May 22, 2018, Special Board Meeting and asked if there were any changes/corrections.

There being no changes/corrections, a **MOTION** was made Supervisor Bell, seconded by Chairman Albertson and unanimously passed to approve the minutes of the May 22, 2018, Special Board Meeting, as presented.

#### G. PUBLIC HEARING

At approximately 10:38 a.m., Mrs. Perez recessed the Regular Board Meeting and simultaneously called to order the Public Hearing.

#### 1. Proof of Publication

Proof of publication was presented that notice of the Public Hearing had been published in the *Miami Daily Business Review* on June 6, 2018, and June 13, 2018, as legally required.

#### 2. Receive Public Comments on Fiscal Year 2018/2019 Final Budget

Mrs. Perez opened the public comment portion of the Public Hearing to receive comments on the fiscal year 2018/2019 final budget and non-ad valorem special assessments. There being no comments on the fiscal year 2018/2019 budget and assessments, Mrs. Perez closed the public comment portion of the Public Hearing.

At approximately 10:40 a.m., with there being no further Final Budget and assessment business to conduct, Mrs. Perez adjourned the Public Hearing and simultaneously reconvened the Regular Board Meeting.

#### 3. Consider Resolution No. 2018-03 – Adopting a Fiscal Year 2018/2019 Final Budget

Mrs. Perez presented Resolution No. 2018-03, entitled:

#### **RESOLUTION NO. 2018-03**

## A RESOLUTION OF THE AH AT TURNPIKE SOUTH COMMUNITY DEVELOPMENT DISTRICT ADOPTING A FISCAL YEAR 2018/2019 BUDGET.

Mrs. Perez read the title of the resolution into the record and stated that it provides for approving and adopting the fiscal year 2018/2019 Final Budget and the non-ad valorem special assessments.

A **MOTION** was made by Supervisor Latchman, seconded by Supervisor Bell and unanimously passed to adopt Resolution No. 2018-03, approving the Fiscal Year 2018/2019 Final Budget, as presented and setting the fiscal year 2018/2019 Final Budget and non-ad valorem special assessment tax roll (Assessment Levy).

#### H. OLD BUSINESS

There were no old business items to come before the Board.

#### I. NEW BUSINESS

#### 1. Consider Approval of Supplemental Engineer's Report

A **MOTION** was made by Supervisor Latchman, seconded by Supervisor Bell approving the Supplemental Engineer's Report, as presented. Upon being put to a vote, the **MOTION** carried unanimously.

#### 2. Consider Resolution No. 2018-04 – Adopting a Fiscal year 2018/2019 Meeting Schedule

Mrs. Perez presented Resolution No. 2018-04, entitled:

#### **RESOLUTION NO. 2018-04**

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE AH AT TURNPIKE SOUTH COMMUNITY DEVELOPMENT DISTRICT, ESTABLISHING A REGULAR MEETING SCHEDULE FOR FISCAL YEAR 2018/2019 AND SETTING THE TIME AND LOCATION OF SAID DISTRICT MEETINGS; AND PROVIDING AN EFFECTIVE DATE.

Mrs. Perez read the title of the resolution into the record and noted that meetings would remain at the same location of the Third Floor Conference Room of the Crexent Business Center located at 6625 Miami Lakes Drive, Miami Lakes, Florida 33014, with the start time of 10:30 a.m. on the following dates:

October 23, 2018 November 6, 2018 January 22, 2019 March 26, 2019 April 23, 2019 May 28, 2019 June 25, 2019 September 24, 2019

A **MOTION** was made by Supervisor Latchman, seconded by Supervisor Albertson and unanimously passed to adopt Resolution No. 2018-04, approving the Regular Meeting Schedule for Fiscal Year 2018-2019, holding meetings in the Third Floor Conference Room of the Crexent Business Center located at 6625 Miami Lakes Drive, Miami Lakes, Florida 33014, with a start time of 10:30 a.m., and authorizes the advertisement of same, as required by law.

#### 3. Consider Resolution No. 2018-05 – Adopting a Statewide Mutual Aid Agreement

Resolution No. 2018-05 was presented, entitled:

#### **RESOLUTION NO. 2018-05**

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE AH AT TURNPIKE SOUTH COMMUNITY DEVELOPMENT DISTRICT, STATE OF FLORIDA, APPROVING THE *REVISED* FLORIDA STATEWIDE MUTUAL AID AGREEMENT; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

A **MOTION** was made by Supervisor Bell, seconded by Supervisor Latchman and passed unanimously to adopt Resolution No. 2018-05, as presented, authorizing the District's participation in and the execution of the Statewide Mutual Aid Agreement by District officials.

#### 4. Qualified Elector (Registered Voter) Certification Announcement

Mrs. Perez stated for the record that she had received from the Miami-Dade County Supervisor of Elections the certified elector count, identifying nine (9) registered voters who reside in the A.H. at Turnpike South CDD ("District") as of May 22, 2018. Since the District had not yet reached the 250 qualified elector threshold, it would continue to elect Board Members by the landowner election process.

#### 5. Consider Resolution No. 2018-06 – Ordering and Call for a Landowners' Meeting

Mrs. Perez presented Resolution No. 2018-06, entitled:

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE AH AT TURNPIKE SOUTH COMMUNITY DEVELOPMENT DISTRICT ORDERING AND CALLING FOR A LANDOWNERS' MEETING AND PUBLIC NOTICE THEREOF FOR THE AH AT TURNPIKE SOUTH COMMUNITY DEVELOPMENT DISTRICT'S ELECTION OF MEMBERS TO THE BOARD OF SUPERVISORS

Mrs. Perez announced that the Landowners' Meeting would be held on November 6, 2018, at 10:30 a.m. at The Crexent Business Center, Third Floor Conference Room, 6625 Miami Lakes Drive, Miami Lakes, Florida 33014, for the purpose of electing Supervisors to Seat Nos. 2, 4 & 5.

A **MOTION** was made by Supervisor Bell, seconded by Supervisor Albertson and unanimously passed to adopt Resolution No. 2018-06, Calling for a Landowners' Meeting for November 6, 2018, at 10:30 a.m. to be held at the Crexent Business Center, Third Floor Conference Room, located at 6625 Miami Lakes Drive, Miami Lakes, Florida 33014, for the purpose of electing Supervisors to Seat Nos. 2, 4 & 5.

#### J. ADMINISTRATIVE MATTERS

#### 1. Financial Report

Mrs. Perez presented the Financial Reports through May 2018 and the Assessment Collections, which were provided in the meeting booklet. She indicated that available funds as of May 31, 2018, were \$47,668.88.

#### K. BOARD MEMBER/STAFF COMMENTS

There were no comments from the Board Members or Staff.

#### L. ADJOURNMENT

There being no further business to come before the Board, the Regular Board Meeting was adjourned at 10:49 a.m. on a **MOTION** made by Chairman Albertson, seconded by Supervisor Bell and the **MOTION** carried unanimously.
